Reference was made by the chairman to the death of Mrs Vicky Dawson, who was to become a co-opted member of the council. Consideration was to be given to provision of some type of recognition.

Comment was made on the fact that the local MP Robert Jenrick had been installed as Secretary of State for Housing Communities and Local Government in the recent changes in parliament following the retirement of Prime Minister Theresa May and the appointment of the new Government leader Boris Johnson. The council gave their best wishes to Mr Jenrick on his new position.

- 2. DECLARATIONS OF INTEREST There were none
- 3. MINUTES OF THE MEETING HELD ON JUNE 25, 2019 were accepted as circulated and signed by the chairman
 - 4 OPEN SESSION FOR MEMBERS OF THE PUBLIC, LIMITED TO 15 MINUTES No matters were raised.
 - CLERK'S REPORT

The clerk said the matter of the VE75 event in May next year comes up in correspondence. A guote had been obtained for the fence between the field and Mr and Mrs Leake.

6. REPORT FROM THE BOROUGH AND COUNTY COUNCIL MEMBER There was no report.

7 CORRESPONDENCE

A letter from the national office of CPRE discussing its future and stating it intended to show a more aggressive attitude yet continue its aim to look after the well being of the countryside.

Paveway, quoted for a fence on the edge of the playing field adjacent to the home of Mr and Mrs Leake in the sum of £3,300. The council agreed to accept the quote subject to Aslockton parish council accepting it in order the account was shared equally between the two councils. The clerk was to advise the adjacent council of the price and also ask them if they did not agree to share the price to advise Mr and Mrs Leake as to why.

Rushcliffe Borough Council confirmed its free trees scheme was to operate again in 2019. Residents could obtain two trees and parish councils were being offered up to ten.

Notts County Council had responded to the request the parish council had made on behalf of residents for a bus shelter on Beverley Avenue and assured the council they would investigate the request.

It had been confirmed that May 8 next year would be a public holiday to allow people to celebrate the 75th anniversary of VEDay. The council agreed that it intended to be part of the celebrations and the chairman suggested a concert style event be held in the Jubilee Hall.

PLAYING FIELD

An update on the position involving the pavilion in particular and the playing field in general was given by Coun. Grocock. Meetings continue to be held and progress was being made in the plans for improvements. The pavilion had been completely restored and had been transformed into a valuable asset that can be used by local residents and groups. Consideration was being given to new play equipment and there were plans to improve the

infrastructure on the playing field with repairs to fences, develop a netted cricket training area and obtaining new sports equipment.

9. PLANNING MATTERS

Planning briefing notes, Chairman Gregg Redford.

Coun. Redford presented a report in which he reminded members that in forming opinions on planning applications only material planning issues can be put forward. He said parts of Whatton are in a Conservation Area and for planning applications in those areas there are special considerations in addition to the normal ones that have to be adhered to.

The chairman also commented on the Rushcliffe Borough Council Local Plan Part One and the Core Strategy and on Part Two of the Plan.

In regard to the way the parish council dealt with planning applications involving the parish, he said where it was not possible to meet the consultation deadline date set by the Borough, it was possible to call an extraordinary meeting with the normal rules applying in regard to notice period and agendas. He said in the event that an application is not discussed by the council at a formal meeting no comment can be made of the application, with this creating the impression of No Objection being the opinion of the council.

The meeting agreed in principle to a Village Fete/Festival on May 8/9 and possibly 10. The Clerk confirmed that the Village Hall had been booked for the night of May 9th. Members were asked to consider the format and scope of the proposed event and bring forward suggestions at the next meeting in September.

15. QUEEN'S WOOD

Coun. Faulconbridge said plans were being formulated to create a volunteer group to help look after the Queens Wood area and to come forward with plans for its future. Some work would require professional help but other tasks could be tackled by volunteers.
